Rev. Dr. Brenda Salter McNeil is a native of Trenton, New Jersey. She earned her Bachelor's degree from Rutgers College, a Masters of Divinity from Fuller Theological Seminary, and a Doctorate in Divinity from Baptist Theological Seminary. She was officially ordained into the ministry in 1985. For over 15 years, Reverend Brenda served on the staff with InterVarsity Christian Fellowship in Chicago. As Regional Coordinator of Multi-ethnic Training, Dr. McNeil lectured nationwide and represented InterVarsity at international conferences. In 1990, Dr. McNeil founded Overflow Ministries, Inc. What began as a small, home-based Bible study is emerging as a worldwide ministry boldly declaring a vision to unite every tribe and every nation. Dr. McNeil's training and passion for authentic race relations has brought her to the attention of renowned pastors, community activists, and other leaders. Rev. Brenda is married to Dr. J. Derek McNeil and has two children.

Pastor Keith Odom was born and raised in Cantonment, FL. He received his calling to the ministry at age 15. During his time of preparation, Pastor Odom served as Administrative Pastor, Assistant Pastor, State Youth President, Chairman of Elders & Minister's Council and Evangelist. Pastor Odom attended Gordon-Conwell Theological Seminary with a focus in Urban Ministry. He also attended Wentworth Institute of Technology and George Washington University. In April 2001, Pastor Odom established Anointed Word Family Worship Center International, a ministry that would reach the wounded and rejected as well as those who have never had a relationship with God. Anointed Word is a dynamic ministry, attracting members and visitors from many ethnic, social and economic backgrounds. Anointed Word has birthed several ministries and businesses to promote the Kingdom of God here on earth. Crazy Praise Christian Entertainment Group, Spirit of David Design & Management Company, Word in Action Community Foundation, and the Anointed Word Family Book Store are a few of them.

I understand that these methods shall be the sole remedy for any controversy or claim arising out of this release and expressly waive my right to file a lawsuit in any civil court against InterVarsity for such disputes, except to enforce an arbitration decision.
