 - a. Progress on tasks:
 - i. CoL numbers

Kim summarized her assessment of the family CoL data. Described a histogram of age distrib., 180 total kids. Saw rent/utilities higher for families as compared to singles, and the numbers match approximately to survey, though the CoL numbers claim \$1000 per month per kid (Age averaging though? Further investigation needed) It was unclear whether childcare questions adequately differentiated between total and individual childcare expenditures.

ii. Family Survey

Jason handed out summary of the data, calculating means, medians, and combined costs of housing, childcare, health insurance for families (individual partners and combined). (see attachment) Ami: Do we have anything on what/why spouses are doing what they're doing (staying home or otherwise)?

Anna: Most int'l students have a visa such that they cannot even apply for work.

Ami: I think there are J visas that can work that still stay home cause childcare is expensive

Kim: Do we have any breakdown of gender of person reporting on childcare costs? Since many men reporting no costs are relying on stay at home spouses.

Randi/Nathaniel: We might look into it with GWAMIT, but we don't have that from this or from CoL

Anna: What is the best takeaway from this?

Randi: Age of children and how many applied for TCC and didn't receive. Getting percentages of students with X attribute would be good. Distributions are more helpful than single stats.

iii. Off-Campus alternatives – Work Life Center Anna investigated infant and toddler care with Work/Life Center. They have a 24 hour resource site. ~25 childcare center, ~20 family daycare options, and then through googling got nanny options. In the total spread, TCC Eastgate and Stata are right in the middle with regard to cost (2300 per month). Lowest was 1200 (religious). Highest was Bright Horizon at University park (2750). For toddlers, similarly 1500 -2400, with TCC at 2000.

Family daycare data: they are much much cheaper. 1000-1800. Median 1200/month. Not much difference between infant and toddler.

Nanny costs based on work/life, 15-20\$ an hour. So about 2700 a month full time (but typically would be sharing).

All this is Cambridge.

Ami: I think the scholarship ended when the on-campus TCC stopped paying facilities. (gotta check this)

Anna, giving Ramya's stuff on preschools: Cambridge, public options low income is free of charge if you qualify, but wait list is 1–1.5 years Bright Horizons slots are available (1500 a month) Learning Center, \$75 a day or \$315 a week

Not many of the centers have a sliding scale based on income. Only a couple out of 20 (but when they do, what % of income they are taking, usually much lower).

iv. Peer institutions

Remi: Looked mainly at Ivy institutes. Out of 8, only 2 offered subsidies. Princeton offers up to 5000 a year per kid (in home out of home). Stipulation was that the spouse has to be working part time/full time, looking/injured. Their daycare is comparable to MIT
