A fellowship (of four thousand Brazilian reais per month) will be awarded to the successful candidate by CAPES.

To apply, please fill out the **application form** attached, and send it, **along with the documents listed below**, to the e-mail address: ppgcts@ufscar.br with “PNPD application submission” in the subject line of the e-mail, by no later than midnight, Brazilian time, **June 10th, 2018**.

Please send attached scanned copies (in PDF format) of the following:

- 1) ID document, with photo, valid in your country of origin. If you do not have an ID, a copy of your valid current passport can be sent (including the photo page).
- 2) Copy of proof of address proving residency, e.g. a utility bill with your name on it.
- 3) Copy of Doctorate diploma, or, if you have not yet finished your Doctor’s degree, but will have by the beginning of August 2018, a letter of proof that you will complete your Doctorate, from the HE institution. You will need to present the Diploma by the implementation date of the fellowship.
- 4) Curriculum Vitae – please see the attached CV form. Alternatively, you can create your “Lattes Curriculum” at: https://www.cnpq.br/cvlattesweb/pkg_cv_estr.inicio and provide us with the link to the online curriculum Lattes.
- 5) Introduction letter (PDF). Maximum 2 pages, noting to which Line of Research at PPGCTS you would adhere, and if you wish, you can mention the name of a researcher from PPGCTS with whom you would like to work. - 6) Research and work plan, in which you detail the research you intend to carry out, and expected results, and its relevance to the PPGCTS Program. You can also include details of prospective course modules that you propose to teach while with the PPGCTS, or of seminars that you can give to students and staff.

IMPORTANT: At the moment of your application submission, you should notify us if you have (or have had) any type of relationship or close friendship with any of the research staff members (list available at: <http://www.ppgcts.ufscar.br/pessoas>).

- Completed application forms, plus relevant documents, to be sent to ppgcts@ufscar.br between 7th and 9th June, 2018, to be received **by no later than midnight, Brazilian time, on the 10th June, 2018**.
- Publication (on Program website) of list of accepted applications - 14/06/2018

- Discussion, via Skype, of the candidate's ResearchWork Plan - 14 & 15/06/2018
 - Publication (on Program website) of the preliminary classified candidate list - 18 /06/2018
 - Publication (on Program website) of the final classified candidate list - 28/06/2018
 - Official notification (via e-mail) of the candidate classified in first place – 28/06/2018
- The candidate classified in first place will have 5 days, between 29/06/2018 and 04/07/2018, to officially manifest interest (via e-mail) in accepting the post-doctoral research place and scholarship. There will then be a period of 30 days from 05/07/2018 to 06/08/2018 for the scholarship to be activated by CAPES.

How your application will be assessed:

Each three parts of the selection procedure – analysis of curriculum vitae, research work plan and discussion of this plan – is worth 10 points. The sum of the attributed points for each part will be divided by three to obtain an average.

For the analysis of the **curriculum vitae**, we will follow the following points system:

The Work Plan will be assessed using the following points system:

Aspects of the Work Plan	Maximum points
1 Content of Work Plan will be assessed on the basis of the following aspects: a) Clarity of the aims and research question; b) Justification and relevance of the proposed research; c) Theoretical framework and references; d) Proposed methodology.	Up to 4 points
2 Adherence: The project will be assessed regarding its pertinence to the STS Postgraduate Program at UFSCar, and to the proposed line of research.	Up to 4 points
3 Project composition: use of the English language, cohesion, coherence, grammar, orthography.	Up to 2 points

The Discussion of the work plan will be assessed using the following points system:

Aspects of the discussion of the Work Plan	Maximum points
1 Clear and articulated oral presentation of the central aspects of the proposed research and work plan.	Up to 4 points
2 Demonstration of a command of the concepts that underpin the proposed research and work plan.	Up to 4 points
3 Clarity and precision of the answers given to the questions formulated by members of the Evaluating Committee.	Up to 2 points
