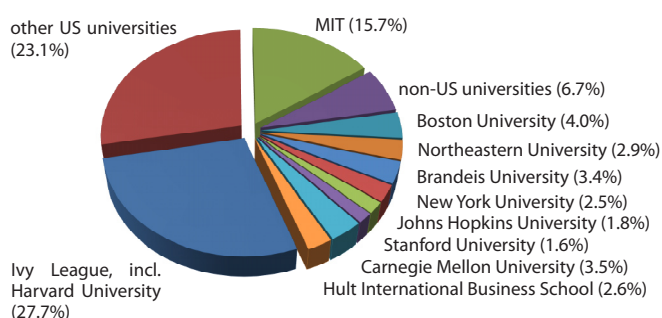
Location: MIT campus, Cambridge, MA, USA.

Our candidates are multi-lingual and have diverse backgrounds. The main fields of study include physical and life sciences, economics, all branches of engineering, business, management and the arts.

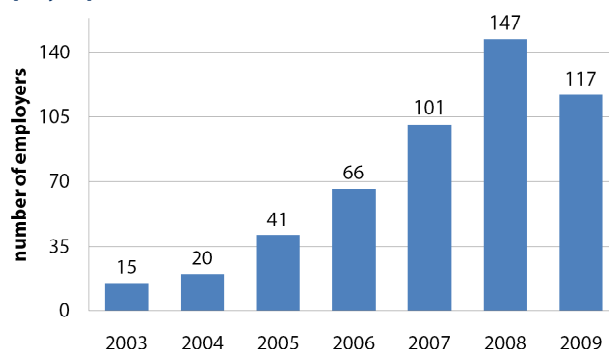


Employer profiles

What to expect from the fair

Attending the European Career Fair is an excellent opportunity to explore the job market in Europe. During the course of the Fair, candidates will have the chance to interview with top European employers seeking to recruit amongst the top candidates in the US. In order to obtain an interview with such employers, candidates are required to follow the steps below:

- 1) Register (highly recommended):** Register as a candidate on our website (www.euro-career.com) and submit your resume online before **November 23, 2009. REGISTRATION IS FREE.** In doing so, companies can find you when searching for potentially interesting candidates in our database. If selected, companies can schedule an interview with you on the interview days (January 31/February 1, 2010).
- 2) Come to the fair.** Wear your business attire and bring your printed resume with you. By talking to company representatives you can additionally secure an interview for one of the interview days; in fact, 50% of the interviews are scheduled on the Fair day!
- 3) The Interview day.** Interviews will take place on January 31 and February 1.
